Introduction

We ask that you read this cookie policy carefully as it contains important information on who we are and our use of cookies or similar technologies on our website. Cookies:

A cookie is a small text file which is downloaded/placed onto your device (eg computer, smartphone or other electronic device) when you use our website. Cookies are used by many websites and can do several things e.g. counting the number of people looking at our website, help us recognise you and your device, remembering your preferences, and store some information about your past actions. We use cookies on our website.

For example, we may monitor how many times you visit the website, which pages you go to, traffic data, location data and the originating domain name of a user's internet service provider. This information helps us to build a profile of our users. Some of this data will be aggregated or statistical, which means that we will not be able to identify you individually.

How does Blackthorn use cookies:

- **Strictly necessary cookies:** These are cookies which enable our website to operate properly, and we place these onto your device. These cookies are essential for you to be able to navigate our website and use its features. Without these cookies, the services you have asked for could not be provided. This includes:
- **Session cookies:** These allow our website to link your actions during a particular browser session. These expire each time you close your browser and do not remain on your device afterwards.
- **Performance cookies:** These cookies collect information about how you use our website, eg which pages you go to most often. These cookies do not collect personally identifiable information about you. All information collected by these cookies is aggregated and anonymous, and is only used to improve how our website works.

The table below provides more information about the cookies we use and why:

Google Analytics Cookies	Google Analytics is a web analytics service provided by Google Inc which uses cookies to show how visitors found and explored the site, and how their experience can be enhanced. The Google Analytics cookies provide information about the behaviour of site visitors (eg how long they stayed on the site, the average number of pages viewed) and also records how many visitors there have been.	
_GRECAPTCHA	_Grecaptcha is a functional cookie used for risk analysis in spam protection and it may also store browsing device information. The cookie is placed by: Google reCAPTCHA	
rc::a rc::b	rc::c rc::f	These cookies are used to distinguish between humans and bots. They are used in order to make valid reports on the use of the website. These cookies are placed by: Google reCAPTCHA
